

# Northwest Arkansas: A Celebration of Crystal Bridges

## May 3 – 7, 2012

### ITINERARY

#### Thursday, May 3 – Northwest Arkansas Regional Airport/Johnson

Independent arrivals, transfer to the four star Inn at the Mill, Johnson, Arkansas. The Johnson Mill, listed on the National Register of Historic Places, was first registered as a tax-paying business in 1835 and bears the distinction of being the longest running business in the state of Arkansas. Enjoy a welcome dinner at the hotel's award winning restaurant. (D)



#### Friday, May 4 – Johnson/Bentonville

After breakfast, we leave by motor coach for Bentonville. Our first stop is at the artfully restored and maintained Walton's 5 & 10. Step back in time to see a store chock full of retro toys, candies, souvenirs and actual memorabilia for sale. Listen for the sounds of yesteryear while examining the original floor tiles or tin ceiling Sam Walton installed.

Next, we visit the new exciting Crystal Bridges Museum of American Art. Alice Walton, the daughter of Wal-Mart founder Sam Walton, spearheads the Walton Family Foundation's involvement in developing Crystal Bridges. The museum's glass-and-wood design by architect Moshe Safdie and engineer Buro Happold features a series of pavilions nestled around two creek-fed ponds. The complex includes 217,000 square feet of galleries, several meeting and classroom spaces, a library, a sculpture garden, and a gathering space that accommodates up to 300 people. Additionally, there are extensive nature trails and exquisitely landscaped gardens.



Our visit will be divided into seeing both the collection and the museum's gardens and trails with lunch at the museum café.

The Crystal Bridges art collection encompasses American art from Colonial times to the present. Familiar names such as Copley, Peale, Stuart and Duyckinck highlight the Colonial collection with 19th-Century artists such as Moran, Durand and Cropsey and Eakins, to Modernists Sargent, Gorky Sheeler, Chase and Porter. Contemporary works include Holzer, du Suvero, Turrell, Cave, Warhol and Oldenburg. These are but a few names in this monumental private collection that we will be privileged to see.

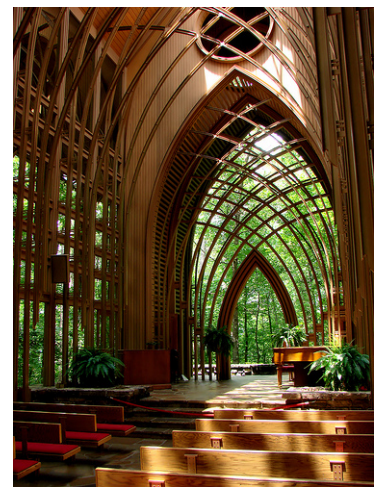
Next is a tour to explore the trails, walkways and hiking paths of the museum's grounds. The accessible woodland of flowering trees and natural springs create an inviting complement to the art museum. The Crystal Bridges Trails & Grounds are set within a forested valley, which on its southern border reaches to within a few blocks of the Bentonville town square. Finally, the group gathers for an afternoon reception at the museum before returning to the hotel.

The evening is free with dinner on your own at one of the many local restaurants. (B/L)

### **Saturday, May 5 - Johnson/ Fayetteville/Bella Vista/Bentonville**

Our first stop is Fayetteville for a tour of the Botanical Garden of the Ozarks. Unlike many public gardens, the gardens one sees today are the result of a volunteer-led, grass roots effort. Adjoining Lake Fayetteville; gardens include the Carl A. Totemeier Horticulture Center, a plaza and great lawn, nine 2,000-square-foot gardens, a greenhouse and other garden features. Various themes are presented, including a children's garden, four seasons garden, herb and vegetable garden, Japanese garden, rock and water garden, Ozark native garden, rose and perennial garden and sensory garden.

We proceed to the Mildred B. Cooper Memorial Chapel in Bella Vista. The Chapel was created by renowned Arkansas architect E. Fay Jones. In 1991, Fay Jones was awarded the American Institute of Architecture's highest award, the AIA Gold Metal. Fay was a student of Frank Lloyd Wright where he was first introduced to the principle of Organic Architecture. Return to Bentonville.



We return to Bentonville to visit the Peel Mansion and Historic Gardens for a lunch and tour. The mansion was built in 1875 by Colonel Samuel West Peel. Much care was taken in erecting this magnificent house, a wonderful example of the Italianate Villa Style. The interior of the house was furnished with authentic antiques and artifacts of the era, generously loaned by the Historic Arkansas Museum and the Old State House.

We end the day at Crystal Bridges where we complete the final tours of the collection before our return to Johnson.

The evening is free to dine at one of the area's restaurants. (B/L/R)

### **Sunday, May 6 - Johnson/Eureka Springs**

Set out for Eureka Springs. Named one of 12 Distinctive Destinations by the National Trust for Historic Preservation, the entire town is listed on the National Register of Historic Places. The first visit will be a tour of the Rosalie House. The Rosalie was built in 1889 by JW Hill, owner of the Eureka

Springs Livery & Stables and the builder of Eureka Spring's phone system. At the time, JW was considered to be the wealthiest man in Eureka Springs. He declared his new home would be "the prettiest and fanciest home on The Boulevard", and it still is today. The Rosalie is a stunning example of Eastlake and Steamboat Gothic architecture, and features extensive "gingerbread" elements.

Enjoy lunch at the 1886 Crescent Hotel, listed as a Historic Hotel of America. Irish stonemasons constructed what's now affectionately referred to as the "Grand Old Lady of the Ozarks" in 1886 with every intention of making it the grandest hotel west of the Mississippi.

Following lunch, we will take a tram tour of Eureka Springs' Historic District. The city has steep winding streets filled with Victorian-style cottages and manors. The old commercial section of the city has an alpine character, with an extensive streetscape of well-preserved Victorian buildings.

We conclude our day in Eureka Springs with a tour of The Queen Anne Mansion. The Queen Anne Mansion is dedicated to preserving and maintaining The Queen Anne estate as a premier destination to experience the finest in American architecture, decorative and cultural arts.
